1. The six monthly progresses achieved under Compensatory Afforestation and CAT Plan during the FY 2022-23 up to 30.09.2022 for Malana-1 HEP is enclosed herewith as Annexure-1

2. We are continuing the facilities of Acupressure, free medicines & providing part time service of qualified allopathic doctor for the people of surrounding villages in addition to our employees.( Details of the patient and budget allocated is attached as Annexure-II along with the CSR & EHS expenditure of last year )

3. We are releasing the minimum 15% discharge in the river course .Online monitoring of the discharge and this six monthly compliance report can be seen on our web site

4. We have planted 1000 nos. sapling of deodar and other species of plants( Robinia, kosh ) in this winter.

- 5. In addition to this we are disposing the solid waste generated in our housing complex through the Solid Waste Treatment Plant of at our sister- concern ADHEPL at Prini Manali. (Detail mentioned in Annexuere III
- 6. Copy of previous consent to operate up to 31/03/2025 has been sent to your office earlier with our official letter no. MPCL/JARI/MOEF/2022-23/87 dated 28.06.2022
- 7. Noise pollution details, e-waste returns and water sample tests results are attached as annexure IV
- 8. Regarding the constitution of multi-disciplinary committee (to check the physical and financial progress of the CAT Plan, compensatory afforestation, and possibility to handing over the unused forest land along with Dumping sites) the matter had been again taken up with the local forest Deptt and is still pending at their end.


